Hall of Legends Nomination Criteria & Application

Criteria

- Nomination Forms Must Be Submitted by April 1.
- Nominees must have made outstanding and significant contributions to the Farrier Industry Association for a significant period of years as a business owner, farrier and/or sponsor.
- Nominees must have been employed (present or past) by a company in good standing with the FIA for a minimum of 2 years.
- The contributions must have been influential to, and supportive of the growth of one of the FIA.
- The nominee must be, or if deceased were regarded as having outstanding character.
- Nominee may be living or deceased.
- The nominee must be (or must have been) regarded as having outstanding character.
- There will be no set number of nominees to be awarded each year.
- If a member is sitting on the Selection Committee, they cannot be nominated for the Hall of Legends.

Nomination Process

- Submissions must contain a completed nomination form highlighting a compilation of achievements, biographical information, related honors, and supporting documentation to illustrate the contributions of the nominee.
- Nominations for Hall of Legends inductees will not be accepted verbally.

Selection Process

- Any FIA member can nominate a person for the Hall of Legends by submitting the listed criteria information to the office or Committee Chairperson.
- The Selection Committee will be comprised of three members from the Hall of Legends who are appointed annually by current Hall members, two FIA Board members seated by Presidential appointment, and the Hall Committee Chairperson. The Hall Committee Chairperson will only vote if one of the voting members abstains or is absent. The FIA President and Executive Director may sit on the Committee as ex-officio members.
- The Selection Committee members will rotate off the Selection Committee every three years, except for the Hall Committee Chairperson, who shall be appointed by the President.
- Nominees will be screened by the Selection Committee, with emphasis placed on the Hall's mission statement and the individual's unselfish contribution to the FIA, and his/her substantial impact on the farrier industry, rather than only on personal achievements.
- The deadline for nominations is April 1 of each year, and the Selection Committee will determine which candidates will be recommended for induction by June 1.
- Nominees that meet the Hall criteria, but that were not selected, will remain on the nominated list for five years for future consideration.
- The Selection Committee decisions are final. The FIA Board of Directors and/or Hall of Legends Committee may not supersede the Hall Selection Committee.
- The FIA Board of Directors will ratify all new inductees.
- Nominee's and/or families will be notified, and Inductees will be formally announced at the FIA Business Conference.
